# Economic Development 4.0

It is my pleasure to include this letter in the SFI Annual Report that recognizes the outstanding projects all across Saginaw County in 2022. Most of us have heard about the transformations taking place in the international marketplace and Industry 4.0, but we are also seeing dynamic changes in what we have termed Economic Development 4.0.



With the drive for electric vehicle development, Nexteer continues to make huge investments within its Global Technical Center and world class U.S. Operations in Saginaw. A national effort to bring home the semiconductor supply chain helped spur a \$375 million investment by leading polysilicon manufacturer Hemlock Semiconductor. Many of the stories included in this publication reflect growing entrepreneurialism, urban investment and the rising creative class. Ox Eye Media, which develops games, comic books and digital media, purchased the Jefferson One Building in Downtown Saginaw. That excitement extends to places like Frankenmuth, which will have the largest indoor water park in Michigan and the Village of Merrill that had a closed school repurposed into 17 market rate apartments and a more than \$25 million investment by Merrill Technologies.

Economic Development 4.0 is here and Saginaw County is capitalizing on those opportunities!

# Hemlock Semiconductor Breaks Ground on \$375 million

The state, through the Michigan Economic Development Corporation, approved \$37 million for infrastructure improvements in Thomas and Saginaw Charter Townships to support a \$375 million investment at Hemlock Semiconductor. The company is a global leader in the manufacture of polycrystalline silicon and the largest producer of high purity polysilicon in the U.S. Polysilicon is used in several products, including the production of semiconductor chips and solar panels.

The investment is expected to create 170 new jobs, according to the Michigan Economic Development Corporation. HSC currently employs 1,350 employees at its headquarters in Thomas Township. The next-generation technologies HSC will deploy through the project will increase the purity of the company's semiconductor-grade polysilicon and improve supply to meet rising global demand. This project is the first phase of planned expansion projects recently announced by HSC. The planned projects will take place in phases over the next three years.

Buena Vista Charter Township received Michigan Strategic Fund (MSF) approval of \$25.5 million in federal Community Development Block Grant (CDBG) Coronavirus Aid, Relief and Economic Security (CARES) funds in support of a project for Nexteer Automotive. It will help secure new equipment for the company's world-class manufacturing operations and retain high-quality jobs at the company's Buena Vista site. Nexteer is a global leading motion control technology company. The company is committed to accelerating mobility to be safe, green and exciting.

The CARES funds are vital in ensuring Nexteer retains manufacturing positions, while continuing to make critical investments at the site both now and in the future. The project is expected to generate a total private investment of up to \$51 million and retain 1,100 jobs. The MSF also approved a 15-year State Essential Services Assessment exemption valued at \$2,273,225 in support of the project. Buena Vista is supporting the project by serving as the applicant for the CDBG CARES grant.

# Highlights Bavarian Inn & FPS

Major Indoor Water Park Expansion Planned at Bavarian Inn Lodge





### FPS Purchases BV Building

Food Process Solutions (FPS) is a global leader of turnkey industrial freezing and cooking equipment based in Richmond, BC. FPS' ties to Michigan developed through a joint venture established two years ago focused on installation of its equipment. In response to market demand, a vacant 130,000 sq. ft. industrial facility in Buena Vista Charter Township was purchased. Phase 1 is the investment of \$6 million in building acquisition and improvements. SFI assisted the community and company with a tax incentive, and 25 jobs will be created.

The Bavarian Inn Lodge water park in Frankenmuth is getting a massive expansion. More than 20 new attractions are planned, including more water slides, a wave pool, and a swim-up bar for adults. When it's done, the indoor water park will be more than 140,000 sq. ft. The \$80 million expansion project began Dec. 13, with plans to open in spring 2024. Some attractions will open in late fall 2023.

"We are truly raising the bar on fun at the Lodge, creating unique attractions and new types of experiences within our resort," said Michael Keller Zehnder, President of the Bavarian Inn Lodge. "This expansion will help us to advance our goal of creating fun and enjoyable experiences for all ages. We are reimagining family fun and see this as an exciting project for all of Frankenmuth."

According to Zehnder, there will be no disruptions to the Family Fun Center, banquet center, hotel rooms, and existing water park amenities.



## Highlights Gemini Capital, Merrill Technologies & Duro-Last

### **Redevelopment in Merrill**

Gemini Capital Management VIII, LLC has redeveloped a former schoolhouse located at 235 W. Saginaw St. and 135 S. Eddy St. in the Village of Merrill. The underutilized building was redeveloped into 17 market rate apartments operated by Gemini Capital.

The investment is more than \$4 million with six jobs retained and 50 temporary construction jobs during the redevelopment phase. The project received a Michigan Community Revitalization Program performance-based loan for \$19.2 million. SFI assisted the company through all the processes to get a Saginaw County Brownfield plan approved and a Commercial Rehabilitation tax incentive approved through the Village of Merrill and County of Saginaw, which were instrumental.



### Large Expansion for Merrill Technologies

Merrill Technologies Group is undertaking a 30,000 sq. ft. addition to its Village of Merrill facility. For more than 50 years, Merrill Technologies has been a trusted partner to world leaders across a wide range of industries, such robotics, chemical, aerospace, heavy equipment and more. The company needed additional floor space for more machinery and equipment. The addition will allow the company to undertake more customer orders. Pumford Construction will begin construction in early 2023. Total investment between building and equipment is expected to be approximately \$25.3 million with 14 jobs to be created over the next two years and 72 retained. SFI is assisting the company and community with a tax incentive.

### **Duro-Last is the Government Contractor of the Year**

Duro-Last Roofing Inc., a national roofing manufacturer headquartered in Buena Vista Charter Township, has been pioneering the development of prefabricated single-ply roofing for over three decades. Duro-Last was encountering resistance and roadblocks for a number of years when attempting to compete for State of Michigan business. In response, the Saginaw Future APEX Accelerator (formerly Procurement Technical Assistance Center) facilitated meetings and discussions with former State Senator Ken Horn and representatives from the Department of Technology to rectify the situation. As a result of those interactions that spanned a long period of time, Duro-Last has bid and been successfully awarded with 400 projects to date. The total amounts to 9.6 million sq. ft. of Duro-Last membrane with an overall total of \$23 million in contracts being awarded.

### New Equipment for Hausbeck

Hausbeck Pickle and Peppers, located in the City of Saginaw, invested nearly \$2 million in machinery and equipment for a stand-up packaging line. The new project not only packages pickles and peppers, it also produces the packaging on site. SFI worked with the City of Saginaw on a Michigan Department of Transportation – Transportation Economic Development Fund grant to improve Hess Ave. where Hausbeck is located.

### **AKT Restoration Work**

AKT Peerless is a long-standing Saginaw company that recently completed major exterior work to its Downtown Saginaw location. The approximately \$90,000 investment focused on the restoration of the exterior brickwork at 214 Janes Ave. The renovations were completed to preserve the exterior of the building that was constructed in 1948.



### **New Growth for Spicer**

Spicer Group expanded significantly in the City of Saginaw, hiring an additional 65 full-time employees and 31 interns, and investing \$1 million. The company purchased new workstations, survey trucks, survey equipment, and material testing equipment to support the additional staff.

### Ox Eye Media Expands into Downtown Saginaw

Owners of Ox Eye Media purchased the Jefferson One building located at 100 S. Jefferson Ave. in Downtown Saginaw for a total investment of nearly \$1 million. The six-story office building built in 1931 currently houses WTA Architects, United Way of Saginaw County, READ Association and others. All are expected to remain as tenants. Ox Eye Media, which develops and publishes board games, comic books, television and movies, will also locate its headquarters in the building. SFI assisted the company with identifying investment opportunities in Riverfront Saginaw.

Ox Eye Media is also renovating a portion of the former Jacobson's building. The company is investing \$1.5 million to upgrade 50,000 sq. ft. to house creative

space and inventory for its retail distribution. S h a h e e n Development is the owner of the building and the developer.



### New Ownership for Mistequay Group

Mistequay Group Ltd. and its facilities in the City of Saginaw and Saginaw Charter Township Michigan, and Monroe, Washington were acquired by Textron Aviation. Mistequay is a supplier of precision components for aerospace and defense manufacturers. The new company will operate as AeroMotion by Textron Aviation and will increase its internal productivity for the OEM's aircraft series. The company recently invested over \$4 million in equipment, will retain all current employees, and looks to continue to add positions in Saginaw County.

### InCal Adds Room for Growth

InCal Technologies, Inc. specializes in providing Gage Calibration and Zeiss CMM Inspection and has grown its machining capabilities by expanding into an adjacent building. InCal has made substantial improvements to the building and has added new CNC equipment. The total new investment is \$403,000.



### KOOPS Acquires Wright-K Technology

KOOPS Automation Systems, a designer and builder of innovative automation systems and equipment for manufacturers, has purchased Wright-K Technology, Inc. SFI has worked with Wright-K for numerous years and recently it was awarded a MEDC Training Equipment Grant. SFI is assisting through the transition and identifying additional business resources.



### New Shop for Frankenmuth

Frank's Muth is a new shop in the heart of Downtown Frankenmuth and offers an uncommon collection of gifts including a variety of popcorn, hot sauce bar, novelty socks and man cave items. It serves cocktails at its indoor bar and patio. A \$300,000 investment resulted in a renovated facility and 13 team members were hired.



### Essex Energy Starts Up in the City of Saginaw

Essex Energy is a City of Saginaw, woman-owned minority and business that started in March, 2021. The company provides utility construction including services. distribution and maintenance for overhead/underground utility lines, and emergency storm restoration. Saginaw Future assisted with government contracting certifications, site location and more.

# Saginaw PROJECTS

### Old Town Distillery Expands Into Adjacent Building



The Old Town Distillery expanded in Old Town Saginaw after originally opening in 2014 to offer hand crafted spirits made in-house. The owner purchased the adjacent building to accommodate a full service kitchen and additional seating capacity. The expansion resulted in an investment of \$75,000 and created four jobs. SFI assisted the business with a façade grant from the Saginaw DDA, as well as with guidance through the Historic District Commission approval process.



### New Walgreens Concept Store

Walgreens constructed а new storefront to allow for a smaller footprint concept at 1841 N. Michigan Ave. This development is a partnership between Walgreens and A&S Properties Associates. The project has an investment of approximately \$1.375 million and included demolishing two existing buildings on the site and developing a new structure and parking lot. The new store will primarily be occupied by the pharmacy.



# Second Location in the City of Saginaw

Elite Cannabis is opening a second retail location on the corner of N. Mason St. and State St. in the City of Saginaw. Development firm, NH Ventures, is rehabilitating a former 7-11 that has been in and out of use for many years. The project will renovate and upgrade the building at 2030 N. Mason St. Plans call for an overall improvement of the site and provide storm water remediation for an investment of approximately \$3 million. Fifteen new jobs are expected to be created. SFI assisted the project through the planning and zoning process.

### Saginaw Public Schools Adds Mosquito Control Land

The Saginaw Public Schools District purchased the Saginaw County Mosquito Abatement Commission (SCMAC) property and is transferring the former Buena Vista administration buildings and adjacent 26 acres to meet current and future SCMAC operation needs. Saginaw Future worked with the Saginaw County Controller/CAO to identify an appropriate site for the relocation of the facility.

### **New Location for Kakes**

Kakes the Great Popcorn Co. is a family based business that specializes in custom treats. Kakes has expanded from a start-up pantry food to its own 2,000 sq. ft. location at 216 Federal Ave. in Downtown Saginaw. Kaylynn Martin, the 16-year-old entrepreneur behind Kakes the Great, said the vision for her whimsical, colorful new store is "a popcorn-meets-candy factory." Eight jobs were created.

### **Brownfield Redevelopment**

Michigan Garage LLC invested nearly \$1.9 million and is creating 10 new jobs. The project consists of demolishing blighted structure located а at 2205 N. Michigan Ave. in the City of Saginaw and the construction of a retail cannabis dispensary. The City Saginaw Brownfield Authority, of administered by Saginaw Future, approved a Brownfield plan to support the investment.

Southgate Building - New Offices for Edward Jones and the LOFT by Pine Island Design

Michael and Jasmine Southgate are constructing a two-story, 2,800 sq. ft. commercial building at 159 S. Main in the City of Frankenmuth for the expanded businesses of Edward Jones and Pine Island Design. The first floor will serve as the office for Michael Southgate and Doyle Webb of Edward Jones Investments and the second floor will be home to the LOFT by Pine Island Design, a full-service interior and exterior design firm owned by Jasmine Southgate. The \$1 million project will also feature a rentable entertainment venue and balcony.

### New Construction for Michigan Brand

Michigan Brand is a processor of specialty meats, hams, sausage and jerky. A new cooler/freezer was added and an additional packaging room was constructed for a total of nearly 8,300 sq. ft. in the City of Frankenmuth. Michigan Brand invested nearly \$2.5 million with 10 jobs created. SFI assisted the company and City with a tax incentive.



### Weiss Equipment Expands in Frankenmuth

Weiss Equipment expanded in the City of Frankenmuth with a new dual-purpose warehouse and shop. The family-owned and operated company is a provider of outdoor power products, such as off-road vehicles, residential lawn and power equipment and more. The new building allows for the use of overhead cranes to increase process efficiency. The \$2.5 million expansion resulted in the creation of three jobs.

### EE Sports and Arcade Open in Downtown

EE Sports & Arcade is a new Downtown Saginaw business that partially opened in March. It began offering sessions for the Golf Simulator. The Bancroft building storefront on E. Genesee Ave. will become a fully outfitted arcade, along with a new restaurant. The \$194,000 investment will result in 16 new jobs.



### AHSRAT Renovation is Moving Forward

A Higher Standard Revolving Around Training & Coaching others (AHSRAT) is a nonprofit that administers entrepreneurial developmental activities to at-risk youth. AHSRAT is renovating a long vacant building located at 1315 N. 5th Ave. in the City of Saginaw. The 2,526 sq. ft. building will require significant upgrades and five jobs will be created.



### Fuerbringer School Being Repurposed

Saginaw House will be a fully licensed Assisted Living/Memory Care Veteran Board and Care Facility. The former Fuerbringer School will be renovated to house 42 residents. The total budget is approximately \$1 million and will result in 26 new jobs. The project was rezoned and received a tax exemption.



### Building Available on Court St. Corridor

MDL Companies constructed a new storefront at 1215 Court St. in the City of Saginaw. The project includes the remediation of the vacant site, and new facility and parking construction. This is an investment of \$1 million and the commercial space is available for lease or purchase. SFI assisted the development through the City's planning and zoning process.

READ Association of Saginaw County added another office suite at the Jefferson One Building in Downtown Saginaw. READ was founded in 1966 with the mission to help students improve reading skills and received a \$25,000 MEDC Match on Main grant.

### Gibbs Music Studio Moves to Dixie Hwy.

Gibbs Music Studio expanded out of a home business to a commercial location at 6215 Dixie Hwy. in Bridgeport Charter Township. In May 2022, Suzanne Gibbs went through the Saginaw Soup process and won second place at the pitch competition.
