is opening a second Saginaw County manufacturing facility in Thomas Township's Great Lakes Tech Park, with support from the Michigan Strategic Fund. The expansion is expected to generate \$8 million in new private investment and add 58 new jobs. Fullerton Tool, founded in 1942 in the City of Saginaw, manufactures solid carbide cutting tools for a vast variety of industries including medical, aerospace, automotive, power generation, heavy equipment, recreation, firearms and mold and die industries. The company has been awarded a \$400,000 Michigan Business Development Program performance-based grant and Saginaw County provided 35 acres of shovelready property to support the project, SFI assisted with site location, project incentive packaging, and Park infrastructure and preparation.

invested an estimated \$92.5 million at its site in Buena Vista Charter Township and added 280 jobs during 2014, making the company the largest manufacturer and employer in Saginaw County. Nexteer attributes its success to its productive employees, innovative technology and the safety, comfort, performance and reliability of its products. Nexteer Automotive is a global leader in advanced steering and driveline systems. Nexteer's in-house development and integration of hardware, software and electronics gives the company an unmatched competitive advantage as a full service steering supplier. In addition, Nexteer is one of the leading participants in the State's Community Ventures Program, which provides meaningful employment to those needing a second chance.

a metro-Atlanta based manufacturer of solar cells and modules, opened a second U.S. facility in Saginaw Charter Township. The company needed an existing building to meet the production schedule of its highlyregarded American-made modules. Suniva is expected to add 350 new jobs to the Saginaw community. The new facility further strengthens Suniva's position as America's leading solar module manufacturer, employing a higher percentage of American workers than any other tier-I solar manufacturer. The company currently produces its high-powered Optimus monocrystalline module line with power ratings up to 280W (60-cell format) and an industry-leading 330W (72-cell format). SFI assisted the company with site location assistance, and state and local incentives.

Hausbeck Pickle Company, Inc. manufactures pickles and peppers used primarily in the commercial quick serve market, and has customers such as Subway, Burger King, Sonic, Papa Johns and others. Custom Foods Inc. made necessary sewer upgrades to allow for the expansion of its tank yard. The facility stores, grades, and brines cucumbers/pickles for the commercial manufacturing and processing of pickles. Property improvements total more than \$319,000 and SFI assisted the company and the City with a tax incentive.









Freeland Bean and Grain Inc. constructed a large storage facility that will house a dryer and conveyor system at its 1000 E.Washington headquarters in Tittabawassee Township. The more than \$300,000 investment will allow for additional process capacity and create approximately three jobs. www.freelandbeanandgrain.com

new equipment to produce larger trusses. This is the second phase of an overall project started last year that added additional square footage to its production facility located in Carrollton Township. The company added 10 jobs in 2013 and another two in 2014. www.midmichigantruss.com

will soon begin construction of a facility located on St. Mary's of Michigan's campus in Downtown Saginaw. The Central Michigan Univeristy (CMU) Board of Trustees approved a \$12 million construction and renovation plan that will provide space for internal medicine and senior health care clinics and a neuroscience center in a 17,100 sq. ft. facility connected to St. Mary's. The project also includes the renovation of the St. Mary's Health Education Center's 250-seat auditorium and two classrooms. Construction begins in spring 2015 and is expected to conclude in summer 2016.

is constructing a 46,000 sq. ft. building on the campus of Covenant Healthcare. The facility will house a state-of-the-art simulation center and four advanced technology classrooms for the CMU College of Medicine. The building will serve as a hub for third and fourth year medical students. The medical school's residency program will use the classrooms, labs, training spaces and library. Eight of the 15 project subcontractors are from Saginaw and all are from within a 75 mile radius of the City of Saginaw. The building is expected to be complete by May 2015. is investing \$16.2 million in new equipment and improvements to its Thomas Township facility. The company will spend nearly \$1.9 million in building improvements and \$14.3 million in equipment. The medical device manufacturer is expected to create a total of 12 new jobs at the site within two years and 27 jobs will be retained. Built in 1964, HIMS was an early pioneer in the development of silicon-based materials for healthcare applications. Today, HIMS serves hundreds of customers worldwide with innovative healthcare products and solutions.



COVENANT HEALTHCARE EMERGENCY CARE CENTER

completed its 11,456 sq. ft. expansion, which adds 18 treatment bays to the existing 47 and also houses a dedicated CT scanner and mini-laboratory.The investment is supported by more than 200 physicians, nurses and nursing assistants along with ancillary staff. SFI serves on the Hospital Bond Development Authority, which issued revenue bonds to support the \$6.5 million project.

SFI, Saginaw County Chamber and former Senator Roger Kahn advocated for the quality of life project and is working with the Museum through the grant allocation process.

Three developers from Ann Arbor and San Diego invested more than \$750,000 in the renovations, which include commercial space on the first floors, and residential on the second and third.

The owners are lifelong Saginaw residents and the chef has more than 20 years of experience. Bradley's is a successful Kickstarter Project (where people are offered tangible rewards in exchange for pledges).

In March 2014, a new law was signed, along with receiving approval by the Michigan Strategic Fund. Shaheen Development's 30-unit, \$3.62 million project will be located on Hamilton St. across the Saginaw River from Ojibway Island. The property was a former vacant manufacturing site and developers will pass along the tax-free status to the condo purchasers.

Duro-Last is a manufacturer of prefabricated roofing systems sold nationwide and in Canada to roofing contractors on low-sloped roofs. The equipment allows the company to localize production of currently outsourced products, expand product offering at competitive prices and control quality of products offered for sale. The project includes an investment of \$750,000 in real property improvements and the purchase of an extruder and mixing system for \$17.6 million. Saginaw Future assisted the company and Buena Vista Charter Township with a tax abatement application, and meetings and tours to acquaint the Buena Vista Board of Trustees with the project and operations.

Alfe Heat Treating, Inc.

is an aluminum heat treating and parts blasting operation at 1300 Leon Scott in the City of Saginaw. The company invested \$4.6 million in new equipment and added six jobs as a result of the investment. The project consisted of the installation of a new precision air quench system, transfer car and conveyors, and a continuous furnace. Saginaw Future and the community helped retain the project with a tax incentive. The Alfe Saginaw Heat Treating Quality System is certified to the ISO/TS 16949 quality standards for aluminum heat treating, shot blasting, and parts washing. In an effort to meet and exceed customer expectations, Alfe Saginaw developed a water blast system which cleans heat treated aluminum parts prior to shipping them to its customer's machining source. Alfe Heat Treating's Saginaw facility was established in 2000 and its company headquarters are located in Fort Wayne, Indiana. Alfe also has locations in Wabash, Indiana; Wadsworth and Defiance, Ohio; and Charlotte, North Carolina.
