



# **Teamwork Wins \$88 Million Investment in Saginaw**

### **An Unprecedented Partnership**

A partnership that was unprecedented in Saginaw's past has brought new opportunity for Saginaw's future with an \$88 million investment in Saginaw Metal Casting Operations (SMCO). In November 2002, General Motors announced that SMCO had beat out competitors in Mexico for the new precision sand business that will produce engine blocks for GM's next generation of aluminum V-8 engines. The investment has also saved 191 jobs at the plant, since GM had previously planned to cut about 200 jobs from the plant. What's more, additional jobs may well be created as local suppliers prepare to meet SMCO's expanding needs. Saginaw Future president JoAnn Crary noted, "The last time there was new investment (\$170 million for a lost foam aluminum line), Saginaw gained four new suppliers and over 250 jobs."

#### **A Collaborative Effort**

Saginaw Future played a key role in facilitating the collaborative efforts of SMCO, the city of Saginaw and the Michigan Economic Development Corporation to develop a strong business case for the project. In addition, plant manager Rick Sutton credits the efforts of the plant's 2,400 employees who helped to save \$75 million in plant operation costs over the past three years, even while starting up production of the lost foam aluminum Vortec 4200 inline-6 engine block and cylinder head for the carmaker's popular line of SUVs.

### **A Winning Combination**

As Rick Sutton explained, "It's important to recognize the strong teamwork that helped make the precision sand project a reality for SMCO. Saginaw Future Inc., the Saginaw City Council and the Michigan Economic Development Corporation worked with the SMCO team to develop a very compelling business case to address our global competitive challenges," he said. "Our outstanding workforce at SMCO helped us achieve our goals in cost and quality. Through the spirit of cooperation with our labor leaders, we have been able to put competitive work agreements in place." Sutton also added, "When you put all of these factors together, you have a winning combination, and that is what made it possible for us to be awarded the precision sand project."





The project's initial stages of research, development and equipment installation began in late 2002, with engine production scheduled to begin in 2006.

### **Unanimous City Council Vote Speaks Volumes for Saginaw**

The successful outcome of the Saginaw Metal Casting Operations project was due in large part to the unanimous vote from the Saginaw City Council to approve a 100 percent personal property tax abatement on the plant's new precision sand aluminum line. This decision will save SMCO about \$16 million in property taxes over the next 20 years, but the significance of the unanimous vote is more than financial.

According to Ed Donovan, Director of Municipal Government Relations for General Motors, "This decision proved to us at GM that the community of Saginaw is willing work with us as we face an increasingly competitive environment so that we can continue to grow our business in Saginaw. It has been refreshing to work with a community that is receptive and positive when it comes to business investment. Like many other manufacturing businesses, General Motors has found that this is not always the case. Saginaw has definitely shown itself to be business-friendly."

Saginaw's Mayor Wilmer Jones Ham added, "As elected leaders for the city of Saginaw, we saw this project as a key opportunity to save and bring new jobs in our community. Because of the teamwork that took place between our own city council, business and labor leaders from SMCO and General Motors, along with Saginaw Future and the Michigan Economic Development Corporation, we were able to send a positive message to both GM and to our community."

# Creative Three-Part Deal Will Revitalize Saginaw's Downtown

In September 2002, the Saginaw City Council approved an innovative development deal with SSP Associates to make big things happen on Washington Avenue in Saginaw. According to the plan, SSP Associates will:

- · Invest \$1.15 million to acquire and restore the 75-year-old Temple Theatre
- Invest \$100,000 to renovate the nearly vacant Saginaw Tower building on N. Washington Ave., and
- Invest \$3 million to build a 30,000-square-foot third floor addition at the Michigan Cardiovascular Institute.

In return, the city turned over ownership of the Saginaw Tower on N. Washington Ave. to SSP for a nominal fee, and also approved 15-year state renaissance

zones for the properties. Without the deal, the Temple Theatre would have continued to decay, facing another winter without heat, utilities or badly needed repairs — and the Saginaw Tower would have continued to stand nearly vacant after two years on the market with no offers.

Saginaw Future worked with SSP and city officials to create the plan, which will continue to revitalize the city's Washington Ave.

corridor. Saginaw Future president JoAnn Crary credits SSP for their "proven track record as successful developers who are committed to Saginaw." In addition, Crary commended Saginaw's city officials and council members for "seeing the long-term benefits of the project."

In offering her support of the plan, Mayor Wilmer Jones Ham referred to the new Temple Theatre as "Fox Theatre North." She also told *The Saginaw News* that she wanted the community to understand that "it's important for the city council to embrace developers who are willing to put their money into the city," she said. "This is another great example of a public/private partnership that benefits our entire community."

# Upgrading "Walkability" Features in Downtown Frankenmuth

Saginaw Future prepared and administered an application to secure a Community Development Block Grant for a downtown revitalization project in Michigan's top tourist destination: Frankenmuth. The city of Frankenmuth was awarded \$585,000 in CDBG funds from the Michigan Economic Development Corporation. Over \$2 million in local matching funds were also provided for the project by the Frankenmuth Downtown Development Authority.

The goal of the project is to expand pedestrian walkways along Frankenmuth's Main Street. CDBG funds were focused on improvements at the Frankenmuth Visitors Center Platz and the Gunzehnhausen Platz — both on Main Street. At the Visitor Center Platz, improvements include new benches, trash receptacles, lighting and landscaping. The Gunzehnhausen Platz, located across the street and one block south of the Visitor Center Platz, will be expanded to accommodate a greater number of visitors along the corridor. In addition, realignment of the traffic patterns near this platz will improve vehicle and pedestrian safety, supporting easier and more direct access to Zehnder's Restaurant.

According to Steve Black, vice president of Saginaw Future, "what really pushed the project over the top is the continued growth and job creation at these two destination restaurants," he said. Frankenmuth's Bavarian Inn and Zehnder's Restaurant expect to hire 35 additional employees as a result of the project.

### **Cooperative Acquires Michigan Sugar Company**

### **Helping Growers Become Owners**

As of February 13, 2002, Michigan Sugar Company was officially acquired by Michigan Sugar Beet Growers, Inc., a cooperative of more than 1,000 sugar beet growers. The formation of the cooperative and acquisition of the bankrupt company was a sweet success for Saginaw County — but it was equally valuable for the entire state. Michigan's sugar beet industry is estimated to contribute approximately \$115 million to the state's economy annually.


SFI played a significant role in the deal from the earliest stages, assisting the cooperative in obtaining \$210,000 in grant funds from the USDA Rural Development Administration to explore the formation of a cooperative. SFI also facilitated a meeting with the MEDC to discuss sugar-related legislative issues — and wrote letters in support of a \$5 million loan from the state. In addition, SFI

helped the budding cooperative secure a USDA Value Added Product Market Development Grant in the amount of \$500,000 for working capital to get the new organization up and running.

In the final deal, Michigan Sugar, headquartered in Saginaw Township, received a zero-interest loan granted by the state of Michigan. The new cooperative also assumed \$18.5 million of Michigan Industrial Development Bonds as part of the acquisition. As a result, the take-over by the new cooperative retained 350 jobs at processing plants in Caro, Carrollton, Croswell and Sebewaing, which now continue to produce and market the "Pioneer Sugar" brand.



# Saginaw is Granted Seven Additional Renaissance Zone Designations

Projects: Additional Renaissance Zone

Saginaw was among several communities to be granted additional Renaissance Zone designations before the law expired at the end of 2002. The program was created in 1996, designating zones as virtually free from local and state taxes for both residents and businesses. Over the course of the program, requirements for new zones became more stringent, making the additional zone designations all the more noteworthy for Saginaw.

### Renaissance Zone Highlights

Of the seven additional Renaissance Zone designations, Saginaw Future worked with Saginaw's City Council as well as state officials to gain the necessary approvals for the following projects:

- The Temple Theatre and the Saginaw Tower on N. Washington Ave. (see article on page 6).
- Expansion of the Agape Childcare Center, located at 2815
   Janes and owned by the Holy Communion Gospel Center, to
   include an early childhood center with classes for
   kindergarten through third grade.
- 39 acres at the former Delphi Plant 2 site. Delphi and the city of Saginaw are exploring a public-private partnership to redevelop this site.
- Portions of the 900 and 1100 blocks of the developing S.
   Washington Ave. corridor were also given designations in anticipation of future development.

Even though the Renaissance Zone program has now ended, the tax-free status of these properties will continue for years to come. In the mean time, Saginaw Future will be working aggressively to market this unique and powerful tool for economic development in Saginaw.

# Business Park and Super Site Feasibility Study for Saginaw County

During 2002, Saginaw Future secured a grant of \$72,800 from the Michigan Economic Development Corporation to conduct a Business Park and Super Site Feasibility Study for Saginaw County. The grant was awarded as a pilot by the MEDC — the first such grant in the state. The Saginaw County Revolving Loan Fund provided \$45,200 as a local match for the project. After reviewing numerous proposals, SFI selected the Fantus site selection practice of Deloitte & Touche as the consultant to conduct the study.

By October 2002, the study was complete and the results were presented to numerous groups including the Vision 2020 Infrastructure and Government foundation teams. The study

results included 10 sites identified by Fantus professionals as "preferred sites" for development of business parks in Saginaw County. Fantus also suggested two other sites that would be ideal for development as "super sites" — large sites that would appeal to new manufacturers or distributors.

The study results have already been used to strengthen proposals for site consultants. Communities with sites identified in the study may also use the results to help with future planning. Most importantly, the process of going through a site feasibility study with a credible site selection consultant puts Saginaw County in a strong position when applying for state funding for a speculative business park in the future.

#### SFI Secures Grant on Behalf of Tri-Counties

In October 2002, Saginaw County received a grant in the amount of \$192,500 from the Michigan Economic Development Corporation for the launch of Link MBS — a planning project to assess telecommunications services and needs in the Tri-County region. Saginaw Future applied for the grant on behalf of Bay, Midland and Saginaw counties in accordance with the MEDC's LinkMichigan initiative, which includes Regional Telecommunication Planning Grants. Now that the grant has been secured, SFI is also administering the planning project.

Steve Jonas, executive vice president of Saginaw Future, is taking the lead on the Link MBS project. As he explained, the need for improving telecommunications capabilities in the area is clear. "According to research conducted by the MEDC and the Technology Policy Group, the Tri-County area is underserved by broadband Internet providers when compared with communities of similar size and population in the state," he continued. "The average Internet dial-up speeds in the region are among the lowest in Michigan. Link MBS is the first step in making sure that Midland, Bay and Saginaw counties remain competitive when it comes to telecommunications infrastructure."

The County of Saginaw's Revolving Loan Fund and the County Controller's office have been instrumental in moving this project forward. The planning process will be completed in June 2003, when an extensive summary of recommendations will be provided for the three counties.
