Established in 1992, SFI is a private, non-profit alliance of local businesses, the Saginaw County Chamber of Commerce, the County and City of Saginaw, I5 local municipalities, education, labor organizations and local foundations.

## Mission

The mission of Saginaw Future is to increase economic opportunity in Saginaw County by facilitating and supporting business retention, expansion, attraction, and new business development. SFI collaborates with business, education, government and community partners to position Saginaw County as a great place to live, work and locate a business.

## Vision

To be recognized as the premier organization providing proactive and focused economic development assistance, striving for diversified growth, increased tax base and job creation and retention for all of Saginaw County.

## Services & Expertise

Saginaw Future assists companies with financial and incentive packaging, state programs, government contracts, identifying and developing sites and provides access to shovel ready FREE land. SFI also serves as an advocate for business investment projects, connects with resources to address workforce needs and serves as a community liaison, through our service contracts with local and state government partners.

## Budget

SFI is a non-profit 501(c)(3) corporation with an annual operating budget of \$1.1 million. The building had been leased to Federal Express, which moved into its new 213,000 sq. ft. location east of this building. Dee Cramer located spiral manufacturing equipment and 14 employees at the site, and expects to hire more employees. The company designs and converts shipping containers into mobile buildings, such as disaster relief centers, medical stations, drive through coffee shops, sports complexes, and even homes. Banner Day increased its reach through the state's Trade Export Promotion program that supported a display investment and adding two employees. The company added on to the facility so it can provide distribution services for other types of merchandise. The City of Saginaw and Saginaw Future have a close relationship with Midwest and support its continued growth and expansion.

The project generated \$5 million in new investment and created 30 jobs, and was supported by a \$105,000 Michigan Business Development Program performance-based grant. In addition to assistance from the Michigan Economic Development Corporation, Saginaw Future worked with Bridgeport and Orchid to explore infrastructure improvements and job training support.

designs and builds automation and test systems primarily for Ford and General Motors. Sales grew 27% in 2016 and employment has reached 125 at its Bridgeport Charter Township location. KUKA invested \$820,000 in a 5-Axis Machining Center, is implementing a Systems, Applications and Products program, and expects to hire another 20 to 30 employees in the coming year, including many engineers. Saginaw Future and Great Lakes Bay Michigan Works! assisted the company with an application for a Skilled Trades Training Fund grant. DURO-LAST ROOFING, INCORPORATED made investments totaling more than \$25 million from 2014-2016, including a new PVC extruder. This resulted in increased business and the creation of 30 new employees. SFI worked with the company and Great Lakes Bay Michigan Works! to help secure a Skilled Trades Training Funds grant that will support Six Sigma, Lean Office and other training. Duro-Last is the world's largest manufacturer of custom-fabricated single-ply roofing system. The company has invested over \$1.7 million since 2010, which began with the acquisition of the long vacant Kelly Tire building. Continuous improvements have been made to the building that now houses administrative, research and development, and engineering staff.

To date, \$500,000 was invested at Hehr International and \$60,000 at Hehr Glass; both are located in the Village of Chesaning. Engineering is also being brought in-house from California and additional space is needed for a longer glass line to produce higher quantities of the insulated glass. Hehr currently lacks space at its facilities for this increased work and are exploring neighboring properties as options for new construction. Saginaw Future will continue to work with the company and the Village of Chesaning to support future expansion and possible road improvements.

celebrated its new project in Downtown Saginaw. The iconic former Saginaw News building is being redeveloped into a 100,000 sq. ft. mixed-use facility. The exterior will feature a pavilion covering 48 vendor stalls for the Downtown Saginaw Farmers' Market. The \$19.8 million projected investment will be secured through a combination of grants, loans, sponsorships, donations and developer equity. SFI, Saginaw DDA, the City of Saginaw, MDEQ and MEDC collaborated to support the project.

## Cathedral of Mary of the Assumption

launched a major restoration project at 615 Hoyt St. The project, which relies mostly upon local contractors, is estimated to cost \$3.5 million. It is being funded by generous donors throughout the diocese. The work to be completed at the 115 year old church includes air conditioning, new flooring, basement, renovation, mechanical and electrical upgrades, interior and exterior lighting, plastering and artistic painting, refurbishing of the stained glass windows and more.

is federal funding targeting the removal of blighted buildings. The City of Saginaw, in partnership with the Saginaw County Land Bank, was awarded \$2.2 million to remove blight in its neighborhoods. The funding is part of \$118.1 million Michigan received from the U.S. Department of the Treasury. This is the second phase of the successful blight elimination program. Between 2013 and 2015, 860 vacant structures were removed in Saginaw. Saginaw Future once again provided grant assistance.

David Strouse and Gino Cicci Cicarella partnered on the project. The total investment for the new restaurant will exceed \$250,000 and they expect to hire 15 employees.

Owners will replace 281 original singlepane windows installed in 1929 and will use \$300,000 in funding from Petros PACE Finance LLC made available through Property Assessed Clean Energy (PACE) financing, which allows businesses and nonprofits to secure financing for energy efficiency improvements and renewable energy system projects.



## The Gallery, Art for Saginaw

opened in the Bancroft Building in late Fall. It features Michigan artists with emphasis on modern and contemporary art that is on display and sold at the gallery. Fifty percent of the proceeds go to the artists and the other half goes to the Saginaw Art Museum to benefit the youth of Saginaw through education, awareness, appreciation and other programs developed by the museum. Plans also include art classes for children and adults, and the hosting of charitable events at The Gallery.
