CIG Invests \$1 Million

Central Insulated Glass (CIG) has built a new facility on Dixie Hwy. in Bridgeport Charter Township. The company required a new facility to produce larger sizes of glass as customer demand increased.

Saginaw Future assisted CIG with its site search, an investment incentive available through Bridgeport and workforce development needs.

The total project investment is expected to exceed \$1 million and will result in nine jobs retained and two jobs created.

CIG is a wholesale glass manufacturer that was established in 2003. Its owners, John and Robin Eagan, have been successful in the glass producing industry for more than 25 years.

The company sees numerous opportunities because of the new facility and its location. The initial plan will be to further target Saginaw, Flint, Midland and Mid-Michigan, followed by the areas surrounding the region and Michigan's southern border areas.

CIG supplies glass products to commercial suppliers, window manufacturers and professional developers.

Star of the West - a Growing Business



Star of the West Milling Co. headquarters are located at 121 E. Tuscola St. in the City of Frankenmuth.

Star of the West Milling Co. is expanding its Frankenmuth Township facilities, adding 643,000 bushels of additional storage and a grain dryer.

The total investment is expected to be more than \$2.2 million and five jobs will be retained. Saginaw Future assisted the company and the community with Star of the West's first investment incentive.

The company provides drying, processing and storage of grains. Star of the West is headquartered in the City Frankenmuth and has storage facilities throughout Saginaw County.

Built by the Hubinger family in 1870, sold to local farmers in 1903 and incorporated in 1920, Star of the West has seen continual growth in size and reputation over the years. The company has expanded from one mill to five flour mills in four different states and has elevators in seven countries.

The company handles wheat, corn, soybeans, processes edible beans and provides local farmers with their crop inputs.

Star of the West's 160 foot high silo in Frankenmuth holds 260,000 bushels of wheat, which is a 35 day supply for the mill. The company's overall daily flour

Star of the West's Flour Division produces a variety of flour for the food industry, including Cardinal Flour, Cracked Wheat, Light Bran Standard, Peerless Flour and Crushed Wheat.

The company's Edible Bean Division has been providing canners and packagers of edible beans with high quality products and services for many years. Some of its products include Navy, Black, Pinto, Kidney and a variety of other types of beans.

John E. Green Expands in Zilwaukee

John E. Green Company invested over \$500,000 in new equipment purchases and built an addition at its Bridgeview Center Industrial Park location in the City of Zilwaukee.

The company added over 6,000 sq. ft. of manufacturing space due to the increase in Hemlock Semiconductor Corporation contracts.

John E. Green is a highly regarded mechanical contractor that specializes in systems for industrial and commercial buildings; water coolant systems to regulate plant machinery; and heating, ventilation and cooling systems.

Next year will mark John E. Green's 100th anniversary, which also has offices in Ann Arbor, Detroit, Highland Park, Lansing, Marquette,

Petoskey and Nashville, Tenn. The new Zilwaukee expansion led to the hiring of 14 employees for the family business now in its fourth generation.

Founder, John E. Green started the company with \$20 as a plumbing and heating business for residential customers in Highland Park. Now the company estimates that its 2007 revenue was \$280 million.

The company credits its succes and growth to the diversification of clients over the years.

T.M. Klein & Sons is a honey producer and specialty jar distributor located in Swan Creek Township. The company had been experiencing growth in its glass distribution business and honey production.

T.M. Klein and contractor Alan F. Schneider constructed a 4,608 sq. ft. building. The company also purchased new honey harvesting equipment. The

total investment is \$225,000 and four jobs were created.

Established in 1976, T.M. Klein began when the family purchased its first hive of honeybees to pollinate the family garden and fruit trees.

The business has grown to approximately 950 colonies of bees. All of T.M. Klein apiaries (bee-yards) consist of 10 to 30 colonies and are dispersed throughout Mid-Michigan in order to pollinate plants.

Each apiary is checked on and maintained once every two weeks in summer, followed by harvesting the honey in August. Each jar is filled, capped, labeled and inspected by hand.

T.M. Klein also distributes a wide variety of specialized jars and containers for small to large wholesale accounts. The "E" friendly company uses all recyclable or reusable glass and plastics.

Opportunity for Wright-K Technology

Wright-K Technology, Inc. recently purchased intellectual property, patents, equipment and inventory of a business being disassembled.

Wright-K, located on E. Genesee Ave. in the City of Saginaw, provides specialty machine design and fabrication, along with the building of testing, laser and metal removal equipment.

Newcor had a solid reputation in the welding industry and approximately \$2 million in annual sales of spare parts production. Wright-K saw an opportunity to acquire the company, which complements and extends its capabilities.

The Saginaw County Revolving Loan Fund, administered by SFI, was able to assist in the development of the project through financing.

Established in 1982, Wright-K will add eight employees due to the acquisition and expansion. The company recently joined a collaborative of 15 companies, which was designated a Tool & Die Recovery Zone. The zones provide tax-based relief and diversification opportunities.

Jonas and AT&T External Affairs Director Gavin Goetz. Saginaw Future Inc., the Disability Network of Mid-Michigan and the Food Bank of Eastern Michigan are all beneficiaries, along with 22 other nonprofit organizations in the state, of AT&T Inc. philanthropy.

Gail Torreano, president of AT&T Michigan, presented grant funds to Saginaw Future - \$20,000, The Disability Network, a Midland-based group that provides training and support for people with disabilities - \$10,000 and the Child Abuse and Neglect

Council of Saginaw - \$15,000. AT&T officials also announced that the company will give \$25,000 to the Food Bank of Eastern Michigan, which includes Saginaw County in its 21-county service area. The contributions bring the AT&T total philanthropic commitment to more than \$450,000 to support Michigan nonprofit organizations.

Region Continues to Benefit from HSC

The Saginaw Valley region continues to benefit from Hemlock Semiconductor Corporation's (HSC) billion-dollar expansion project in Thomas Township. HSC, a Dow Corning joint venture, has leased the long-vacant, former Thompson Boat building in the Village of St. Charles.

The company is using the 100,000 sq. ft. facility for warehousing operations to temporarily store new equipment that will eventually be located at its Hemlock facility.



In addition to the new investment, the HSC project benefits the regional economy in a number of other ways. Nearly 70 area contractors are building new additions to the facility that will ultimately create 500 jobs and produce cutting edge product. The polycrystalline silicon made in Hemlock will be used in electronic and solar devices all over the world.

The HSC expansion has also impacted a number of local companies that supply HSC with products or services. Businesses, such as R&R Ready-Mix and John E. Green Company that are included in this publication, credit increased work for HSC as the reason behind each of those companies' recent expansions.

The billion-dollar development and the projects directly related to it has also substantially increased tax base on a local, county and state level.

New R&R Ready-Mix Facility in Hemlock

R&R Ready-Mix Inc.'s Hemlock location is located at 432 Pine St.



R&R Ready-Mix Inc. is expanding and growing at its Hemlock location. The company invested nearly \$1.7 million in the site and for the purchase of new equipment.

R&R Ready-Mix demolished its old structures, located at 432 Pine St., and is erecting a new state-of-the-art facility that will also include storage.

The company attributes the expansion to its increased work with and the expansion taking place at Hemlock Semiconductor Corporation, which is R&R's primary customer.

R&R Ready-Mix plans to hire three additional workers as a result of the new investment. Saginaw Future assisted the community with developing a tax abatement policy and the company with its first ever investment incentive.

The concrete manufacturer provides building materials, such as ready-mixed concrete, cement and concrete blocks, tiles and flagstones, sand and gravel.
