



# Buena Vista Receives Public Works Grant





Saginaw Future successfully applied for a \$142,900 grant from the Michigan Economic Development Corporation to support the project.

Residents in this vicinity have experienced low pressure in the past and are at risk during certain break scenarios of being without water for potentially extended periods of time.

Additionally, this project also supports a secondary feed into the Buena Vista Commerce Centre Industrial Park that serves a number of manufacturers. In the event a water demand was necessary for future development, the current condition of the system would in fact stifle development.

This project tremendously benefits numerous area residents and the businesses located in the industrial park by increasing the water quality and addressing safety issues.

The new water main loop will be extended on Hack Road, under I-75, and connect the east and west sections of the township.

Rigger machines are also used for construction projects, shipping and transport industry, rigging and millwright support, and plant relocations. In addition to its standard product lines, the company also produces customized lift equipment in order to meet specific or unique lift requirements.

# **Hehr Glass**



The Hehr Glass Company recently purchased new equipment that will allow the company to provide a requested type of glass to its current customer base. Hehr Glass, located in the Village of Chesaning, is a division of Hehr International Inc.

Hehr Glass fabricates laminated transparency products for architectural and transportation applications. For personal and property protection in public or private spaces, the company produces traditional glass laminate constructions as well as sophisticated polycarbonate, glass-clad polycarbonate, bullet-resistant and smash proof laminates.

Hehr Glass, established in 1987, invested \$347,000 and is expected to hire nine employees due to the new product line.

The company's products are used in very diverse projects, such as zoos, aquariums, baseball parks, prisons and detention centers. Hehr Glass products can be found in overhead installations for building entrance canopies and skylights, open-air bus shelters, as well as in auto and transportation applications.

SFI provided investment incentive assistance and also helped the company with an expansion in 2000, which resulted in the hiring of 26 employees. Hehr Glass is one of four Hehr International glass divisions with locations in Newton Kansas, and Los Angeles and Pomona California.

# **Communities Approve Resolutions**

City of Saginaw and Buena Vista



Charter Township leaders unanimously approved resolutions stating the willingness to transfer more than \$61 million in tax abatements from Delphi Corporation to a new buyer.

Both resolutions also declared a willingness to offer new incentives to create more jobs.

"Whether the plants sell or stay with a restructured Delphi, the best thing Buena Vista Township can do is to prepare," said Township Supervisor Dwayne A. Parker.

Delphi, which filed for Chapter 11 bankruptcy protection in October, is in the process of restructuring that may include the sale, downsizing or relocation of the two Saginaw County facilities.

The city and township approved the existing tax abatements in the mid-1990s. The resolutions do not actually transfer the tax incentives. The governing bodies would have to decide whether to approve the transfer once a purchaser is in place.

"We are more than willing to do anything possible to keep those jobs in Saginaw," said City Councilman Willie Haynes.

Saginaw Future assisted in the prepartion and presentation of the resolutions and is currently working with the Michigan Economic Development Corporation, Senator Mike Goschka and Delphi on forwarding legislation enabling PA 328 (100% personal property tax abatements) to transfer to any subsequent owners.

# RLF Assists AHB Tooling & Machinery, Inc.

AHB Tooling & Machinery, Inc. is expanding in Kochville Township, adding five new employees and investing \$240,000 in its operations that are headquartered in Saginaw County.

The company recently purchased a competitor in the Detroit area in order to expand its market presence in southeast Michigan, which led to the hiring of five new employees at its headquarters.

The Saginaw County Revolving Loan Fund, which is

The Zilwaukee branch, located on 5175 Westervelt Rd., has seven workers and three support staffers with the company's main focus being residential and church customers.


